**Seek immediate medical attention if you experience:**

- Severe dizziness
- Inability to stay awake
- Hallucinations
- Heavy or unusual snoring
- Slow breathing

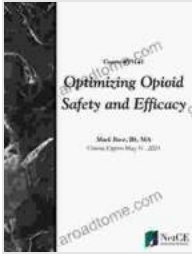

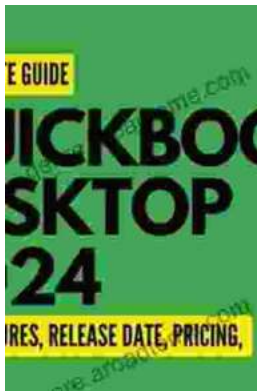
